Economic Model

5.1 Native Token of the Institute Platform – ChaseX (CHX)


The total supply of CHX tokens is set at 1 billion, with a linear decreasing issuance model to ensure that early contributors receive fair rewards while also encouraging new participants to join.



- Ecosystem Development: 40% (400 million CHX) will be allocated to incentivize community development, marketing, business partnerships, and other efforts to help build and expand the CHX ecosystem.
- Team and Early Contributors: 20% (200 million CHX) is allocated to reward the efforts and contributions of the team members and early participants.
- Foundation: 15% (150 million CHX) is dedicated to supporting the operation and development of the foundation.
- Partners and Advisors: 15% (150 million CHX) is reserved to maintain long-term relationships with partners and advisors.
- Community Incentives: 10% (100 million CHX) will be distributed to the community through airdrops, mining, and other methods to incentivize participation in various activities on the Institute platform.

5.2 Token Mechanism

1) CHX Token Output: Proof of Stake (POS) Consensus Algorithm
The CHX token utilizes the Proof of Stake (POS) consensus algorithm. Users are
required to purchase mining machines, which then generate tokens through the
POS mechanism as a form of reward for the users.



2) CHX Token Applications: Network Governance and Transaction Medium The CHX token serves multiple functions within the Institute platform. First, users who hold CHX tokens can participate in network governance through voting, enabling them to vote on major platform decisions such as protocol upgrades, parameter settings, and more.
